


The Telecom Italia Group operates in all the sectors of the advanced communications chain, with highly developed business in fixed-mobile communications and the Internet with the brands Telecom Italia and TIM; multimedia and television (MTV Italia); in the term of the sector and the sect office & system solutions (Olivetti); in research and development (Telecom Italia Lab). It is mainly present in Europe, the Mediterranean Basin and South America. At June It is mainly present in Europe, the Mediterranean Basin and South America. At Juhe 30, 2013, the Telecom Italia Group is the largest fixed telecommunications operator in Italy, with about 13.6 mln retail physical accesses and a broadband portfolio equal to 8.8 mln accesses (6.9 mln retail and about 1.9 mln wholesale). The Group has also more than 31.7 million mobile telephone lines. Abroad, TIM Brasil is the second largest operator by number of mobile lines (about 72.2 mln), providing mobile telephone and convergent services. In Argentina, the Group has increased its stake in Classon field and the second basis of 20 the second telephone and convergent services.
